**TOUR de TERRACE RULES AND REGULATIONS  
FOR BOOTH VENDORS**

It is understood that Tour de Terrace, its officers, directors, employees and agents are held harmless from and against any and all liabilities which may arise out of acts and/or negligence of the participant, or the participant's employees or other persons acting on behalf of the participant.

Participant further agrees to hold Tour de Terrace, its officers, directors employees and agents harmless from and against any and all product liability claims which may arise out of the sale of products by the participant in the show. Participant agrees to obtain all proper licenses needed to conduct business and agrees to collect all taxes required by the State of Washington.

Applications must include fees. If you are forced to cancel, you may receive a 50% refund if the Tour de Terrace committee is notified prior to **June 10<sup>th</sup>**. No refunds will be given after that date. There will be no refunds due to weather. A \$25.00 fee will be imposed on all returned checks and payment must be made in cash. If space is available after **June 30<sup>th</sup>**, payment for booth rentals, canopies, electrical requirements, etc. must be made with cash, cashiers check or money order. No personal or business checks will be accepted after that date.

**VIOLATION OF ANY OR ALL OF THESE RULES AND REGULATIONS MAY RESULT IN PARTICIPANTS BEING ASKED TO LEAVE THE FESTIVAL.**

You must be in operation during Arts & Crafts hours on the dates for which you have paid. **Early pack up and/or leaving are prohibited.** Set up and tear down is permitted during designated times only, as explained in confirmation letter you will receive. There will be no exceptions. It is the vendor's choice to remain open during the later hours in which the carnival and entertainment stages are open.

Booths may be left up overnight at the sole risk and responsibility of the vendor/participant. All products should be removed from booths left overnight. Vendor/participant are responsible for their own booths. **Tour de Terrace assumes no responsibility for lost or stolen items.**

Vendor/participant agrees to set up its booth within the designated space set forth by Tour de Terrace. Displays and chairs may not extend booth boundaries except 2 feet in front. Vendor/participant agrees to have booth ready for business each day prior to festival opening times.

Booth construction must withstand all weather conditions and maintain the philosophy of Tour de Terrace. No signage promoting tobacco or drug use or promotion may be used. If needed, booth canopies are available for a nominal fee, as outlined in the fee section of this prospectus. Please reserve canopies in advance. No tarps will be permitted in the booth areas. Items left behind at Sunday's closing will be donated to charity.
